DESCRIPTION OF AIRCRAFT of the Declarations or an aircraft qualifying under the provision on Insuring Agreement VII. AUTOMATIC INSURANCE FOR NEWLY ACQUIRED AIRCRAFT is actually being used for in flight training in accordance with the terms of an agreement signed by the Named Insured, the following special coverage provisions shall apply:

1. While the certificate addressee is under contract to provide in flight pilot training service to the Named Insured, as respects Liability Coverage D - Single Limit and Property Damage Liability, the definition of Insured includes the certificate addressee and any of its officers, directors, partners, members, managers, agents and employees while acting in the course and scope of such service. However, no such person or organization is an insured as respects his, her, or its liability for the design, manufacture, sale, or modification of the aircraft.
2. The liability insurance as to the interest of the persons or organizations described in Paragraph 1 above shall not exceed the limit(s) for Coverage D set forth in Item 3 of the Declarations or the amount set out in the agreement with the Named Insured, whichever is (are) less.
3. The Company waives any right to recovery it may have against the certificate addressee because of payments it makes for physical damage in accordance with Insuring Agreement III. PHYSICAL DAMAGE COVERAGES, but only to the same extent that the Named Insured has waived its right of recovery for such physical damage against the certificate addressee.
4. The Company reserves the right to cancel the policy or the endorsement to which this certificate refers at any time as provided by its terms, but in such case, the Company shall notify the certificate addressee at his, her or its address, when, not less than thirty(30) days thereafter, such cancellation shall be effective as to the interest of the persons or organizations described in Paragraph 1 above.
